

1. THE MAIN FEATURES

Definition, features and multiplicative effects which can be activated

A SEZ is defined by Legislative Decree 91/2017 (which then became law 123/97) as: "a geographically delimited and clearly identified area, located within the borders of the state, also consisting of non-territorially adjacent areas provided that they have a functional economic link, and which includes at least one port area....(omitted)".

The governing body of the SEZ is a steering committee formed by the Extraordinary Government Commissioner who chairs it (L. Budget 160/2019 and Decree Simplifications - Legislative Decree 16/07/2020, no. 76, art. 46), the President of the Port System Authority (AdSP), a representative of the region (or regions if it is a multiregional area), a member of the Presidency of the Council, a member of the Ministry of Sustainable Infrastructure and Mobility, a representative of industrial development consortia (if one exists).

A company which enters the SEZ can potentially benefit from a localisation package, i.e. a series of incentives:

- 1. State incentives: represented by a tax credit of up to 100 million euros per investment and the reduction of income tax by 50% for those who start a new business;
- 2. Regional incentives: each region may make resources available for investment in SEZs;
- 3. Administrative and bureaucratic simplifications: state, indicated in the law "simplification" of 12/2019 and by decree 77/2021 and local which each region or municipality may decide for itself;
- 4. Decree 77/2021 also provides a simplification of the system of governance of the SEZ by strengthening the activities and powers of the Commissioner who will take charge of the single authorisation procedure and will be the main interlocutor for economic actors interested in investing in the relevant territory;
- 5. Closed Customs-Free Zone: which allows goods imported into Italy from non-EU countries to benefit from the exemption of VAT and duties;
- 6. Favourable credit conditions: the law has provided for the possibility of stipulating agreements or affiliations with banks to encourage business investment.

SEZs can also have an important multiplier effect on the territory

- The container traffic of the Ports which have an SEZ has grown by 8.4% yearly on average.
- Public resources have a multiplier effect of 1 to 3: every euro in public tax credit creates 2 more euros in the private sector.
- An analysis carried out on a panel of free zones shows an increase in the export rate of 4% per year in addition to that generated on the territory.
- Each euro invested in ports creates another 2.5 in the economy.







Based on these principles and guiding elements, 2 SEZs have been defined in the Apulian area: the Apulia-Basilicata (or Ionian) SEZ and the Apulia-Molise (or Adriatic) SEZ. These are the only two interregional SEZs in Italy made with contiguous areas which do not have an outlet to the sea1. In the analysis we will focus exclusively on the Apulia part.

Interregional Ionian SEZ (Apulia side) - extent, sectors concerned territory served, relevant ports

The Ionian interregional SEZ covers a total of 2,579.41 hectares of which 1,518.41 are in Apulia. It focuses for the Apulian part on three main logistics hubs: the port of Taranto, the airport of Grottaglie and the Intermodal Centre of Francavilla Fontana. The table shows the municipalities included in the SEZ as well as the production sectors of greatest vocation in the area which are potentially affected.

THE ENCLOSED CUSTOMS-FREE ZONE

The Taranto Customs-Free Zone - approved by law 160/2019 (art. 1 paragraph 360 letter B) - can be one of the success factors, together with the Ionian SEZ, especially in terms of attracting international port traffic.

The Free Zone, approved with determination by the national director of the Customs and Monopoly Agency, was built in the territory of the port area and includes areas which are not contiguous but functional to each other such as warehouses for the storage of goods and parking lots, as well as the presence

¹ art. 4 bis of Decree Law 91/2017, converted into the law of 3rd August 2017 no. 123, states that "regions which do not have port areas having such characteristics may file an application for the establishment of a SEZ only in associative form, if contiguous, or in association with a port area having the characteristics referred to in Paragraph 2". So, Basilicata and Molise, as they do not have port areas, have chosen to participate in the process of setting up the SEZ in an associative form to the Puglia region, based on a strategy of expanding their productive fabric towards the neighbouring Ionian-Apulian area.









of customs controls for the control of incoming and outgoing goods at the access gates.

In summary, the enclosed Free Zone will allow:

- 1. areas where goods from non-EU markets can be exempt from VAT and customs duties;
- 2. the promotion of the storage of goods which can be stored by the importer for an unlimited time before being replaced on the market;
- 3. the stimulation of the re-export phenomenon, attracting businesses which have this need.

OTHER LOGISTICS INFRASTRUCTURES

The Logistics Plate of Taranto

The Platform, covering around 200 thousand square metres, is located in close proximity to the maritime terminals and the national railway network. It is proposed as a centre for intermodal interchange and the provision of goods services. It is also equipped with a railway terminal, inside the perimeter, consisting of 4 sets of tracks.

Airports

The SEZ area includes the airport of Taranto Grottaglie. With its pre-eminent cargo-logistics function, the airport, already an integral part of Alenia's international program for the on-site production of the fuselages of the Boeing 787 "dreamliner", is currently undergoing further development as a strategic European infrastructure for the growth of the industrial and academic system at the service of the aeronautical and aerospace sector. In this regard, Virgin Galactic has recently shown interest in starting a business line at Grottaglie airport for the launch of satellites and suborbital flights.

2. THE ADSP - THE MAIN NUMBERS

The port of Taranto constitutes the Port System Authority of the Ionian Sea. Overall the AdSP manages approximately 4% of the Italian handling of goods and represents approximately half of the values handled by Apulia, reaching a value of approximately 8.5 million tons in the first half of 2021. The port of Taranto specialises in the handling of bulk goods and is also developing opportunities in the container sector following the concession of the terminal with a capacity of 2/2.5 million TEU to the Turkish group Hilport.

3. LOGISTICS COMPANIES IN THE AREA

In June 2021, Puglia had 6,975 logistics and transport companies, 6% of the Italian total. Of these, 12% are concentrated in the province of Taranto.

By analysing the supply chain, we can observe that the category of "Land transport via pipelines" is the most important component, singlehandedly representing 70% of all the companies in the Transport and Logistics sector, in line with the Italian figure, followed at a distance by 25% by the "Warehousing and transport support activities" sector; the importance of the "Sea and waterways transport" and "Postal services and courier activities" divisions is very insignificant.

4. FINANCIAL INCENTIVES AND SIMPLIFICATIONS

The incentives provided for in the Special Economic Zone have an administrative, infrastructural and fiscal nature (tax credit), and are intended for new and existing companies, "which initiate a program of entrepreneurial economic activities or incremental investments in the SEZ". In particular, the incentives are:

- Simplified authorisation schemes: the single SEZ authorisation
- A single point of access for businesses: the Port System Authority's (SUA's) administrative One-Stop Shop, supported by an SEZ Office
- Reduced time for procedures
- Simplified customs processes

The offer of the Apulia Region guarantees the attractiveness of the SEZ through multiple opportunities which complement the existing national offer.




- Who?: Small companies registered in the Chamber of Commerce for no more than 5 years which intend to initiate or implement investment plans with technological content in the Apulia region. Requirements on the website www.sistema.puglia.it/tecnonidi.
- Eligible activities: The proposed initiatives must be linked to one of the innovation areas listed below:

The minimum value of expenses for the acquisition of tangible and intangible assets is €25,000. The TecnoNidi measure provides for the granting of the following incentives:
 - 80% of eligible operating expenses, in the form of a grant, for an amount not exceeding €80,000.00.
 - 80% of eligible investments, for an amount not exceeding €200,000.00, divided equally between a grant and a repayable loan;

- Who?: NIDI is an active labour policy tool of the Apulia Region which supports self-employment and self-entrepreneurship among women, the unemployed, the economically vulnerable, people who are about to lose their jobs and young people. Requirements on the website: www.sistema.puglia.it/nidi

- Eligible expenditures:

The costs of **investment** which can be financed are:

- production machinery, plants, various equipment and commercial vehicles;
- non-personalised computer programs;
- construction and similar works (which also include fixtures, electrical, thermo-hydraulic, air-conditioning, telephone, telematic and energy production systems, prefabricated and removable structures and soil arrangement costs), up to 30% of the sum of the previous entries.

The costs of **management** which can be financed are:

- raw materials, semi-finished products, consumables;
- rental of real estate or rental of production equipment;
- utilities: energy, water, heating, telephone and connectivity;
- premiums for insurance policies;
- fees and subscriptions for access to databases, for software services "cloud" services, information services, housing, Internet domain registration, search engine positioning services, purchase of spaces for Web Marketing campaigns; website customisation services acquired by companies operating in the sector of software production, IT consultancy and related activities.
- Value of the contribution: For all facilitated initiatives, the repayable loan is provided in the form of a loan of 60 months' duration (84 months for loans over €60,000.00), with a fixed rate, equal to the EU reference rate. centive contract and to participate in a technical assistance session aimed at illustrating the methods of implementation and reporting of the financed expenses and of the reimbursement of the financing share. During the meeting, the companies will formalise the request for the first installment of the facilitated loan. This is followed by the creation of the investment and the obtaining of another 2 shares of the incentive. Once the investment has been completed, all the shares of the relative incentive have been obtained and the suppliers are proven to have paid, a contribution is also obtained for management costs. MINIBOND FUND 2014-2020 - Allocation of the measure equal to 40,000,000 euros.

- This is a financial instrument, established pursuant to Regulation (EU) 1303/2013, aimed at supporting the development plans of SMES which have the potential to issue Minibonds supported by government guarantees, favoring complementarity with the bank credit system through the use of an alternative channel which translates into recourse to the capital market.

- Puglia Sviluppo has identified RTI Unicredit S.p.a. (leader) and Unicredit Bank AG as the Arrangers for the structuring of Minibond operations. The Arranger supports the issuing companies during the structuring process, identifies institutional and professional investors and creates the vehicle company which subscribes/buys the Minibonds, placing the Notes with Institutional and Professional Investors.

- Eligible expenditures:
 - a) Tangible and intangible assets in the Apulia region
 - b) Current assets
- How?: Each SME supported by the Arranger, which is worthy from the point of view of financeability by institutional and professional investors, issues the Minibond. The Minibonds, taken as a whole, are subscribed or purchased by the vehicle company established pursuant to law 130/1999 and subsequent modifications and integrations, and used as assets to guarantee Notes placed with Institutional and Professional Investors. The phases of issuing the Minibonds by the SMEs and the Notes by the Vehicle Company end on near or coincident dates.

Puglia Sviluppo intervenes with a limited portfolio guarantee which provides coverage of the risk of the first losses of the Minibond portfolio.

The guarantee percentage at the issue date does not exceed 25% of the risk









exposure at the portfolio level (thickness of the junior tranche). The guarantee rate to cover the first losses, which constitutes aid, is 80%. The residual guarantee rate (20%) is granted against payment on the basis of the "exempt premiums" framework.

- How is the Minibond portfolio composed? The amount of the Minibond portfolio, to be structured through the use of the resources referred to in the Fund, is equal to 100,000,000.00 euros. Minibond's portfolio should consist of a set of bonds with the following characteristics:
 - a. newly issued and with a maximum duration of 7 years, possibly including a maximum pre-amortisation of 12 months;
 - b. made up of individual Minibonds in an amount of between 2,000,000.00 (two million) euros and 10,000,000 (ten million) euros;
 - c. regulated at the contractually established rate of remuneration through the payment of coupons, against the raising of capital.

Benefits:

- The financial benefit of the public contribution to the Fund shall be fully transferred to the final recipients in the form of a reduction in the rate of remuneration of the minibonds. For the aid scheme please refer to the website http://www.sistema.puglia.it/SistemaPuglia/fondominibond
- Puglia Sviluppo provides direct subsidies to issuing SMEs for the partial coverage of 50% of the expenses related to the structuring and organisation of the issuance of Minibonds. The grants are aimed at partially covering the following expenditure:
 - a) structuring fees to be paid to the Arranger for costs aimed at structuring and contracting activities (one-off expenses for law firms relating to the drafting and revision of contracts and other one-off costs due to agents);
 - b) costs of obtaining credit ratings from ECAI (External Credit Assessment Institutions) recognised by ESMA (the European Securities and Markets Authority);
 - c) costs for the certification of the latest budget.

5. FOREIGN TRADE "BY SEA"

Apulia's maritime trade, which amounts to over 6.1 billion by 2020, has a very significant weight in overall regional trade, accounting for 46% of the total compared to 34% for Italy; in other words, almost half of the goods exchanged from Apulia travel by sea, especially in the import phase. Between 2019 and 2020 the lockdown effect of goods affected the region's maritime trade, causing a double-digit decline (-19%) which was in line with Italy overall (-17%). When





compared with national data, however, the data of the decline in imports are slightly better than the national data (-22% vs -23% for Italy) while in export the decline was more significant than the national data (-15% vs -10% for Italy). This is due to the type of goods exported or the main destination countries. It must be said that although the weight of maritime trade on the regional total is significant, it is still small on the national maritime level (3%); the proper activation of the SEZ can effectively help to increase its contribution.

The commercial exchange by sea in Puglia is dominated by means of transport, machines and the agricultural-agro-industrial sector, metal products and the chemical sector. During the lockdown, the transport sector in particular suffered from a significant block/reduction of activities along the entire Supply Chain.

From a geographical point of view, among the top five destination areas which overall cover 80% of trade, the first maritime partner of Apulia is North America which makes up about a quarter of the overall trade, followed by the non-EU European countries with almost the same weight and East Asia (led by China) with 16%, then comes the EU27 with 14% and Central South America.
